## Program

As the Office of Developmental Programs (ODP) funding for direct service providers and supports coordination organizations moves into the Prospective Payment System and direct billing to the state through PROMISE, agencies are required to be in compliance with a variety of Medical Assistance requirements. This webinar assists in understanding the specifics of this compliance.

At the conclusion of the webinar, the participant will be able to:

- discuss and summarize the legal duties and responsibilities of a provider under the ODP contract, *Provider Agreement for Participation in Pennsylvania's Consolidated and Person/Family Directed Support Waivers*,
- describe and examine basic federal and state laws and regulations applicable to Medical Assistance providers,
- understand various Person/Family Directed Support Waiver requirements under Medical Assistance regulations,
- comprehend basic regulatory requirements related to confidentiality issues, and
- review key criteria for compliance programs.
