#### Federal Department of Labor Rolls Out Proposed Overtime Rule

Recently, the Federal Department of Labor (DOL) announced its new proposed overtime rule. The DOL is proposing to raise the overtime threshold from the current level of \$23,600 (\$455/week) up to \$35,308 (\$679/week).

In 2016, President Obama overtime proposal would have taken the threshold to \$47,476 (\$913/week) and Governor Wolf's 2018 proposal would take it to \$47,892 (\$921). Unlike previous proposals, the rule is not expected to include an automatic escalator.

More information about the proposed rule is available online. The DOL encourages any interested members of the public to submit comments about the proposed rule electronically at this website, in the rulemaking docket RIN 1235-AA20. Once the rule is published in the Federal Register, the public will have 60 days to submit comments for those comments to be considered.

## Federal News

#### MedPAC Addresses Evaluation of Episode-Based Payment System for PAC

One of the topics on the agenda at the March 2019 Medicare Payment Advisory Commission (MedPAC) public meeting focused on the evaluation of an episode-based payment system for post-acute care (PAC). MedPAC advises Congress about the federal programs (Medicare and Medicaid). Over the years, there have been many discussions regarding whether the federal government should implement one payment system across post-acute providers, which vary greatly in how they are paid. Postacute providers include inpatient rehabilitation facilities (IRFs), skilled nursing facilities (SNFs), home health agencies, and long-term care hospitals (LTCHs). During the March presentation, MedPAC shared that they favor a stay-based system, rather than one tied to a whole episode of care for fear that the episode of care would encourage providers to discharge patients early. The Department of Health and Human Services (HHS) will work with an outside vendor to build a unified PAC payment model with a goal to submit it to Congress by 2022. #### Updated IRF Provider Preview Reports Available

The Centers for Medicare and Medicaid Services (CMS) recently updated the inpatient rehabilitation facility (IRF) provider preview reports. The data contained in these reports is based on quality data that was submitted by providers between Quarter 3 for 2017 and Quarter 2 for 2018 and reflects what will be published on IRF Compare when the site is refreshed in June 2019. Instructions are available for providers on how to review the reports. The reports will be available for providers to review until April 3, 2019. ### CMS Establishes IRF-PAI Clinical Help Desk

The Centers for Medicare and Medicaid Services (CMS) has established an inpatient rehabilitation facility patient assessment instrument (IRF-PAI) clinical help desk for providers to submit questions about the IRF-PAI that are clinical in nature. #### IRF-PAI Section GG Decision Tree Document Posted

The Centers for Medicare and Medicaid Services (CMS) recently posted a Coding Section GG Decision Tree document to assist providers with coding inpatient rehabilitation facility patient assessment instrument (IRF-PAI) self-care and mobility data items.

### CMS Releases Updates for Round 2021 of DMEPOS Competitive Bidding Program

The Centers for Medicare and Medicaid Services (CMS) has released information and updates for the Round 2021 of the Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program, which will consolidate the competitive bidding areas (CBAs) included in Round 1 2017 and Round 2 Recompete by conducting Round 2021 in the same geographic areas for a total of 130 CBAs. CMS will shift some items to different, smaller product categories to accommodate the lead item pricing methodology. Round 2021 will include 16 product categories, including new items - off-the-shelf (OTS) back braces, OTS knee braces, and non-invasive ventilators. As a result of the smaller product categories, CMS states that each individual supplier location on a bid must meet all accreditation and state licensing requirements for each item in the product category covered under a contract.



## Brain Injury

#### New CDC Data on Sports & Recreation-Related Traumatic Brain Injury

The Centers for Disease Control and Prevention (CDC) released new data contained in a Morbidity and Mortality Weekly Report (MMWR) report, "Emergency Department Visits for Sports and Recreation-Related (SRR) Traumatic Brain Injuries (TBI) Among Children – United States, 2010–2016."

Some of the data includes:

- An estimated 283,000 children seek care in US emergency departments each year for a sports-or recreationrelated TBI
- ▶ Contact sports contributed to nearly half (45 percent) of the SRR-TBI visits examined
- The activities with the highest number of SRR-TBI visits included: football, bicycling, basketball, playground activities, and soccer
- ▶ Males and children aged 10–14 and 15–17 were most likely to sustain an SRR-TBI

The report includes prevention efforts and strategies to reduce the risk for SRR-TBI, including but not limited to limiting player-to-player collisions through rule changes, teaching strategies to reduce opportunities for head impacts, and using pre-participation athletic examinations to identify athletes at increased risk for TBI.

#### Pennsylvania Disability Data

The Pennsylvania State Data Center has issued a report on Disability in the Commonwealth 2013–2017. It includes information on trends for age, sex, race, ethnicity, education, income, occupation, and disability characteristics for the 1.73 million Pennsylvanians who have at least one disability.

Key trends include:

- A higher percentage of females and older persons had disabilities;
- Ambulatory, or movement-based, disabilities were the most common type; and
- Those with disabilities had lower educational attainment and earnings.

#### **CCBHC Update**

#### Excellence in Mental Health and Addiction Treatment Expansion Act (S 824/HR 1767) Reintroduced

Statement from Linda Rosenberg, National Council

WASHINGTON, D.C. (March 14, 2019) — The National Council for Behavioral Health is pleased the Excellence in Mental Health and Addiction Treatment Expansion Act (S 824/HR 1767) was reintroduced today. We thank the original sponsors, Sens. Roy Blunt (R-Mo.) and Debbie Stabenow (D-Mich.), with Reps. Doris Matsui (D-Calif.) and Markwayne Mullin (R-Okla.), as well as the new bipartisan co-sponsors.

Congress created the Certified Community Behavioral Health Clinic (CCBHC) program in 2014 as an eight-state, two-year, demonstration project for states to improve access to evidence-based care, addiction treatment, and mental health care; improve care coordination; and provide 24/7/365 access to emergency care. Today's reintroduction of the Excellence in Mental Health and Addiction Treatment Expansion Act seeks to renew the CCBHC demonstration program in the original eight states for two years and expand it to 11 additional states.

The passage of the Excellence in Mental Health Act began to address the desperate demand for treatment of addictions and mental illnesses. The eight states are leading a bold shift in this country, transforming community services from a patchwork of underfunded and overburdened organizations into a thriving array of clinics that provide patient-centered care. This important legislation would allow current innovation to continue for another two years, expand the opportunity so others struggling can get effective care, and enable important analysis and learning that can be shared nationwide.

The CCBHC model represents a critical advance in coordinating and integrating addiction care.

Early results from the two-year program demonstrate that 94 percent of CCBHCs report an increase in the number of persons receiving treatment for an opioid use disorder (OUD), and 92 percent of CCBHCs offer at least one type of FDA-approved medication-assisted treatment (MAT), either on-site or via referral to an outside program. Expanding the model will allow more communities to respond to the opioid epidemic that is ravaging the country.

Once again demonstrating their leadership and ongoing commitment to science-based community treatment, the National Council looks forward to working with Sens. Stabenow and Blunt, and with Reps. Matsui and Mullin, to pass the bipartisan Excellence in Mental Health and Addiction Treatment Expansion Act (see this statement online). <

## Drug & Alcohol

#### Corrections Officials Announce Plans to Expand Medication Assisted Treatment

The announcement was one of several commonwealth events held as part of "Stop Overdoses in PA: Get Help Now Week." The Department of Corrections (DOC) is expanding Medication Assisted Treatment (MAT) to now include methadone and buprenorphine as standards of care where determined appropriate. The long-term goal is for the DOC to provide all FDA approved medications to treat and manage addiction within its facilities.

Expansion of MAT includes:

- Medication-Assisted Opiate Detoxification: For new commitments, parole violators, and diversion cases;
- Maintenance: For those individuals who are committed to the DOC and who are already receiving MAT; and
- Initial Prescriptions: For those individuals who are committed to the DOC and who are not in need of detoxification, but who could benefit from MAT from the time of DOC commitment.

"This agency is treating substance use disorder as the chronic disease it is rather than as an acute illness," said Steve Seitchik, who serves as the DOC's MAT program coordinator.

Reports show that there are high rates of fatal overdose and non-fatal overdose among individuals leaving prison; that MAT is more effective than no MAT; and that MAT more than doubles the rates of opioid-abstinence outcomes in randomized, controlled trials comparing psychosocial treatment of opioid use disorder with medication versus no medication.

"We are on the right course for setting our reentrants on the path to a successful return home after incarceration," Seitchik said. "Expanding our program will help individuals while they are in prison, as they prepare and plan for their release, and upon release through a continuity of care."

The continuity of care part of this initiative was an issue previously, because reentrants did not have their Medical Assistance (MA) benefits restored in time for their release. Now, through a cooperative effort with the PA Department of Human Services (DHS), benefits are in place at the date of an individual's release from prison, ensuring the MAT continuity of care.

The DOC also received a \$3.2 million grant from SAMHSA that will allow the agency to provide multiple Vivitrol injections prior to release from prison. "That is expected to have a positive effect on retention in treatment upon release from prison and even better outcomes than we've seen so far," said Tracy Smith, who serves as the DOC's Director of Treatment Services. Funds also will be used to pilot the use of Sublocade, which is injectable buprenorphine. According to Smith, "The DOC is partnering with other state agencies and communitybased stakeholders to ensure effective and expedited continuity of care for individuals who receive Sublocade."

Also at this event, officials provided access to specialty staff who administer the program and to inmates who participate by receiving medication.

This and additional information is available on the DOC website. The above are major advances in the criminal justice community as they relate to substance use disorder. Having benefits in place the date of the individuals' release from prison, and making MAT available to all who will benefit from it, are advances that RCPA and other stakeholders have worked hard in advocating to make happen. ◄

### Transformation to Competitive Employment Act

IDD

Congressman Bobby Scott (D-VA-3), Chairman of the House Education and Labor Committee, Senator Bob Casey (D-PA), and Rep. Cathy McMorris Rodgers (R-WA-5) introduced the Transformation to Competitive Employment Act of 2019 (HR 873 / S 260). This Act provides states, service providers, subminimum wage certificate holders, and other agencies with resources to help workers with disabilities transition into competitive, integrated employment. The Transformation to Competitive Employment Act is legislation designed to strengthen and enhance the disability employment service delivery systems throughout states while subminimum wages, which are currently allowed under Section 14(c) of the Fair Labor Standards Act, are phased out over a six-year period. Currently, under Section 14(c), employers that obtain a certificate are permitted to hire individuals with disabilities at less than minimum wage. The Act would include some grant money to assist states and certificate holders in transforming their organizations' other purposes. The bill also proposes a prohibition of issuing any new 14 (c) certificates.

Providers who currently operate services under this section have expressed concern that this bill does not allow for choice for individuals who chose to work in community rehabilitation programs (resulting in the elimination of jobs), and that the proposed rate of wage increases in the phase-out period does not truly allow time for adjustments for providers (within six months of the enactment of the act, individuals would need to be compensated at 50% of minimum wage). Change at this pace could result in many individuals losing their current employment with such a short time frame to adjust to the change. <

### Chapter 6100 Regulations Delayed Again

Deputy Secretary Ahrens shared with the IDD Committee recently that the publication date of Chapter 6100 regulations has once again been delayed. Early May is the soonest we can expect to see the regulations published in the *PA Bulletin*. As a result, all anticipated dates of implementation of the various parts of the regulations are also delayed. We will continue to keep members up to date with any movement in this regulatory package. In addition to this delay, the proposed waiver amendments have also been delayed in submission to CMS. The timeline for the implementation of those proposed changes is now anticipated to be in the fall of 2019. ◄

### ABLE Age Adjustment Act Reintroduced

On March 5, Senators Bob Casey (D-PA), Jerry Moran (R-KS), Chris Van Hollen (D-MD), and Pat Roberts (R-KS) reintroduced the ABLE Age Adjustment Act (S 651). The bill amends the Stephen J. Beck, Jr. Achieving a Better Life Experience (ABLE) Act to increase the maximum age of onset limit from before 26 to before 46. This change would allow more flexibility in the eligibility for use of an ABLE account. ◄

### RCPA Children's Steering Committee Hears from Office of Youth and Families Deputy Secretary Cathy Utz

The Children's Steering Committee heard from Deputy Secretary Utz about the budget and priorities for the division for 2019. The following highlights were noted:

- > 2.8% increase in the needs-based budget plan
- Providers should give input to your county children and youth office budget for 2020/21
- Family First is seeking a legislative delay until April 2020 for these provisions:
  - o Protocols to prevent inappropriate diagnoses that lead to inappropriate placements in non-foster family settings
  - o Fingerprint-based criminal records checks of national crime information databases, and child abuse and neglect registry checks on any adult working in a child care institution
- Extension of Chafee aftercare services to former foster care youth to age 23 and education and training vouchers to age 26 is appropriate. Considerations include documented and expected outcomes for youth receiving these services and the availability of state and local funding as the expansion would need to be implemented, absent additional federal funding.
- Model licensing standards for foster family homes
- Delay the effective date for the Title IV-E funding limitation until October 1, 2020
- Expand prevention services
- Kinship Navigator programs beginning
- RTF convenings and outcomes
- Act 33 Child Fatality and Near Fatality Review
