Frequently Asked Questions

WHAT IS RCPA PAC?

- A nonprofit, non-partisan, political action committee of the Rehabilitation and Community Providers Association (RCPA). The PAC was created to preserve quality health care in our state, to help members pursue a stronger advocacy role, and to achieve greater political potency for our provider members. Participation is strictly voluntary.
- RCPA PAC allows individuals to combine resources with peers who share their views. PAC contributions support elected officials and candidates for elected office who champion critical issues to Pennsylvania's health and human service providers. To achieve this, RCPA PAC sets an overall campaign goal every year.

WHAT DOES RCPA PAC DO?

- Speaks on behalf of health and human service providers in a strong, unified voice more resources equal increased power.
- Helps pro-health and human service candidates achieve or maintain public office.
- Encourages active member participation in the political process.
- Builds and maintains key relationships in both state and federal government with lawmakers who are supportive of our members' interests.

WHY SHOULD YOU DONATE?

- RCPA PAC makes the health care community more effective. We need to send out a universal message and make our presence known.
- RCPA members must keep pace with other interest group PACs! Our future, and the futures of those we serve, are in our hands.
