Hi Rick,

We have completed the FY 2021/2022 draft fee ranges for ID/A non-residential services including the enhanced communication fees – please see the attached. The fee ranges reflect ODP's comments regarding using 29% for the enhanced communication wages, omitting sign-on bonuses, and adding the Director staff level for Companion, In-Home and Community Supports, Respite, and Community Participation Services.

Please note the following regarding the attached documents and resulting fee ranges:

- The first PDF attachment contains the ID/A Non-Residential FY 2021/2022 Fee Range exhibits. *You will find the base fee ranges on pages 1-2, and the enhanced communication fees on pages 3-4.*
- The second PDF attachment contains the ID/A Non-Residential Assumptions Log, outlining each of the cost component assumptions that were applied for ID/A non-residential services per discussions with ODP.
- For the development of these fee ranges, Mercer used the wages most recently published by BLS, adjusted to reflect the \$14.25 Philadelphia minimum wage (where applicable) and 10% overtime assumption
- We'd like to point out that the lower bound of the FY 2021/2022 fee ranges for some services are above the current fees. This occurs for Companion, Homemaker/Chore, In-Home and Community Supports, Respite, and some CPS services.

In terms of next steps for ID/A, Mercer plans to:

- Deliver the residential and ineligible fee ranges/assumption log: *October 29 target date*
- Deliver the PDS fee ranges/assumption log: *November 5 target date*
- Provide the ID/A fiscal impact analysis: *TBD based on ODP final fee selection*
- Submit the ID/A rate summary report: *Late November*

It may be helpful to review the attached documents on a call later this week to discuss some of the assumptions and results. Please let us know if ODP would like to meet, and we will send over some proposed times.
