Rick,

Per your conversation with Holly this morning, we are providing updated residential ineligible and residential fee ranges.

For residential ineligible, we made the following changes:

1. Removed the \$14.25 minimum wage assumption that was applied to the lower bound
2. Provided the net fee range (reflecting the removal of the participant contribution amount) instead of the gross fee range; this is consistent with the fee currently published on the ODP fee schedule
3. Updated the assumption log to reflect the revised lower bound wage

For Residential, we made the follow change (which only affects Respite Only Homes and Licensed Respite Group Homes):

1. Updated the residential ineligible portion of the fee to reflect the removal of the \$14.25 minimum wage

The lower bound for Respite Only Home and Licensed Respite Group Homes has been decreased due to these changes. Given that ODP selected the lower bound fees in the file you provided on 11/16/21, would ODP like to reconsider the fees for these services using the updated fee ranges?

Please let us know if you have any questions or concerns after reviewing the revised fee ranges. We will provide the final fiscal impact analysis once ODP provides the selected fees for PDS and residential ineligible services.
