We have almost finalized the residential fees, but we are working to wrap up a couple of open items on the respite group homes. We plan to send the final residential fees on Monday.

Regarding respite group homes, please confirm that in the last update cycle ODP selected Licensed Respite Group Home fees

by utilizing the fee ranges provided for Licensed Group Homes with Day Activities. The current fees for these two services do not match, but they are similar.

Also, it appears Mercer provided fee ranges for 1-person 24-Hour Respite (Respite Only Home) services in the last update cycle, but the current ODP fee schedule includes only 2-, 3-, and 4-person services. Please let us know if you would like Mercer to provide the 1-person fee ranges for Respite Only Home services.
