I received updated residential ranges last evening and they did not move as much as I had hoped. I will go back to Mercer again and see what else we can do. Here are the 3 numbers you asked for as the assumptions currently stand:

Fiscal impact at preferred percentiles: \$518M
Fiscal impact at low end and **some** decreases: \$315M
Fiscal impact at low end and no decreases: \$407M
