

Enterprise Incident Management (EIM) System Enhancements and Upcoming Training Opportunities

ODP Announcement 23-007

AUDIENCE:

Providers, Supports Coordinator Organizations (SCOs) and County/Administrative Entities (AEs) that report or manage incidents in the EIM system, including those who are designated as Incident Management Representatives

PURPOSE:

To provide information about EIM system enhancements, available resources, and upcoming training opportunities related to the January 14, 2023, EIM implementation of Medication Error Report changes, the Medication Error Visual Analytic Dashboard, and Medication Error Canned Report.

DISCUSSION:

On Saturday January 14, 2023, the Office of Developmental Programs (ODP) released enhancements within the EIM system. With this release, EIM users will benefit from updates that have been made to the system related to **medication errors**. To facilitate medication error trending and oversight, updates were made to the Medication Error Incident Report and a medication error visual analytic dashboard was created. In addition, a new EIM Medication Error canned report was created to facilitate the use of the Medication Error Dashboard and the analysis of medication errors. For more specific
