Outcome Goal End Date is Overridden by Eligibility Segment End Date

With the 90.20.00 release, any Outcome goals that were already end-dated prior to the start of the new eligibility segment will remain end-dated with their respective dates.

Prior to the 90.20.00 release, when a new eligibility segment was created, previously end dated outcome/goals were being overridden to end on the day before the new eligibility segment.

Slowness for ECO Details Report for Some County/Joinders When Searching for Inactive Consumers

With the 90.20.00 release, the Early Intervention Early Childhood Outcomes (ECO) Report will require an overnight batch request to return results for record status = 'inactive.'

Reason for Change

Prior to the 90.20.00 release, users were experiencing slowness when running the Early Intervention Early Childhood Outcomes (ECO) report for inactive consumers, causing the report to time out. Research of this issue determined a new batch needed to be created for offline reports.

HCSIS: ODP Consumer Eligibility Exception Report Times Out

With the 90.20.00 release, users will no longer have access to the Consumer Eligibility Exception Report. This report is being retired on June 24,2023.

Reason for Change

Prior to the 90.20.00 release, the Consumer Eligibility Exception Report was timing out when users selected to run the report for a county with a large volume of data (e.g., Allegheny). Research on this issue determined that this report was not run frequently; and, therefore, the report could be retired.

HCSIS: Provider Experiencing Common Error on Alerts Screen When Using ODP-BAS Scope

Description of Change

With the 90.20.00 release, providers who log into HCSIS and select the scope of **ODP-BAS** will no longer see alerts related to **ODP-MR** consumers. If the provider selects *Needs Group Misaligned with Needs-Based Service*, *Service Status Set to Unauthorized*, or *ISP Set to Approved* as the alert subject in the search criteria, the message "No records match your search criteria" will be displayed for the user.

Reason for Change

Prior to the 90.20.00 release, providers who logged into HCSIS and selected the scope of **ODP-BAS** had the ability to view alerts for **ODP-MR** consumers. If the user selected the More... hyperlink next to an alert related to the subject of ISP Set to Approved, the system displayed a HCSIS common error. This issue was resolved by preventing providers logging into HCSIS with a scope of **ODP-BAS** from viewing the alerts for **ODP-MR**.

HCSIS: Rates are Not Updating When There is a New Rate for Services

Program Office(s) Impacted	Work Item
Office of Developmental Programs – Bureau of Supports for Autism and Special Populations (ODP-BSASP)	Bug 2745056

Description of Change

With the 90.20.00 release, users will have the ability to view edited service details for a service including an individualized rate. After the individualized rate is edited, the status will correctly display as 'Pending' vs. 'Authorized' in the Authorization Status field. Users will have the ability to authorize the pending service using the 'Authorize Service' function in HCSIS.

HCSIS > Financial > Individual > Authorize Service

Reason for Change

Prior to the 90.20.00 release, if a user edited a service associated with an ISP and changed the individualized rate to a different rate, the edited service would display as 'Authorized' vs. showing as 'Pending' in the Authorization Status field. Since the service was shown as 'Authorized', users did not have the ability to authorize the service using the 'Authorize Service' function in HCSIS.

PWIM: Provider User Experiencing a PWIM Error When Creating an Incident for Individual Not Associated with a Placement Office

Description of Change

With the 90.20 release a validation message 'This incident cannot be created because the Individual is not associated with any Placement Office. Please reach out to the Region to transfer this record', instead of a PWIM common error, will appear when an incident is created for an individual who is not associated with any program office.

Reason for Change

Prior to the 90.20 release, a common PWIM error was thrown when trying to create an incident for an individual who is not associated with a program office.
